**A RESOLUTION RESCINDING RESOLUTION # 11-03-79-05
AUTHORIZING A RESIDENTIAL LAND LEASE WITH AN ATTACHED
MORTGAGE TO [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home, and

WHEREAS, Resolution #11-03-79-05, authorized a land lease for residential purposes to be given to [REDACTED] for establishing her home with financing obtained from the Mille Lacs Band of Ojibwe Housing Department; and

WHEREAS, the residential lease was to be for a period of 35 years and renewable for an additional 15 years, and is subject to the lease provisions, effective June 7, 2005; and

WHEREAS, said land is described as follows:

Part of Tract 410 T 1001 located in the North one-half (N ½) of the Northeast one-quarter (NE ¼) of Section Twenty (20), Township Forty-three North (T43N) Range Twenty-seven West, (R27W) Mille Lacs County, Fourth Principal Meridian, more particularly described as follows:

Lot Forty-one (41), Bugg Hill Plat. The lease site is approximately 1 acre more or less; and

WHEREAS, rescinding Resolution #11-03-79-05 is being requested by the lessee due to none use; and

WHEREAS, signed documents by the Lessee requesting rescinding Resolution # 11-03-79-05 is attached as exhibit A as a part of this resolution.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the Rescinding of Band Resolution #11-03-79-05; and
