**JOINT RESOLUTION 13-02-53-08**

**A JOINT RESOLUTION APPROVING THE BLOOD QUANTUM INCREASE, BASED ON NEW ENROLLMENT ORDINANCE, SECTION VIII. A.**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe, and

WHEREAS, the Minnesota Chippewa Tribal Executive Committee has adopted a new Enrollment Ordinance by Resolution No. 116-03, passed July 30, 2003 at a regular meeting of the Tribal Executive Committee, and

WHEREAS, the Mille Lacs Band Assembly has reviewed the following documentation, and

WHEREAS, based on Enrollment Ordinance VIII. A. the blood quantum of [REDACTED] born 1885 will increase blood quantum from [REDACTED] and

WHEREAS, due to his full sibling [REDACTED] having a blood quantum of [REDACTED] and

WHEREAS, included are copies of appeal letter, enrollment cards, family sheets, Mille Lacs annuity roll from 1998, the 1941 Base roll.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly approves the above individual's blood quantum increase, based on the new Enrollment Ordinance, Section VIII.A.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 17th day of July, 2008 at Isle, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.


