RESOLUTION 13-02-64-08

A RESOLUTION AUTHORIZING A LAND LEASE FOR RESIDENTIAL PURPOSES TO THE MILLE LACS BAND HOUSING DEPARTMENT (MLBHD)

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, the Mille Lacs Band Housing Department respectfully requests a land lease for Residential purposes; and

WHEREAS, the lease will be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and

WHEREAS, said land is described as follows

A part of Tract 410 T 15, located in the West one-half of the Southeast one-quarter of the Northwest one-quarter of the Northwest one-quarter (W1/2SE1/4NW1/4NW1/4) of Section Twenty-eight (28), Township Forty-three North (43N), Range Twenty-seven West (27W), Fourth Principal Meridian, Mille Lacs County, Minnesota, more particularly described as follows:

Commencing at the Southeast corner of said Allotment 15; thence North 1 degree 32 minutes 17 seconds West, assumed bearing 624.23 feet along the east line of said Allotment 15 to the southerly right of way line of Ataage Drive as established on a survey dated March 9m 1982 by Anthony Kerick, RLS No 12266; thence South 89 degrees 24 minutes 44 seconds West 71.60 feet along said right of way line to the point of beginning of the tract of land to be described; thence continuing South 89 degrees 24 minutes 44 seconds West 100.00 feet along said right of way line; thence South 0 degrees 35 minutes 16 seconds East 200.00 feet; thence North 89 degrees 24 minutes 44 seconds East 100.00 feet; thence North 0 degrees 35 minutes 16 seconds West 200.00 feet to the point of beginning. This lease site is 1 acre more or less.


NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby authorizes a land lease for the property described herein for residential purposes be issued to the Mille Lacs Band Housing Department for a period of 25 years, renewable for an additional 25 years subject to the lease provisions, effective upon date of approval; and

BE IT FURTHER RESOLVED, that the lessee will utilize the land in conformity with the provisions of the lease within twelve (12) months of the effective date of the lease, and if all terms of the lease are not met, the land will revert to the Mille Lacs Band of Ojibwe; and

BE IT FURTHER RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above-described property for more than thirty (30) consecutive days after the 1st year anniversary of the effective date of the lease without the prior approval of the Band Assembly; and

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 26th of August, 2008 at Hinckley, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
