**A RESOLUTION IN SUPPORT OF THE APPOINTMENT OF
CHRISTINIA THOMAS TO THE MINIMUM INTERNAL CONTROLS
(MICS) ADVISORY COMMITTEE.**

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the National Indian Gaming Commission is seeking nominees for a tribal advisory committee to assist in further refining and updating the Minimum Internal Controls (MICS) regulations relative to 25 CFR Parts 542 and 543; and
- WHEREAS, the Gaming Regulatory Authority Board is formally requesting that Christinia Thomas' name be submitted to the NIGC as a nominee to participate in this new MICS Advisory Committee; and
- WHEREAS, Christinia Thomas has an extensive background and experience in the gaming regulation field; and
- WHEREAS, Christinia Thomas' experience in drafting and implementing regulations has given her a solid base and allowed her to attain an understanding of gaming regulations from start to finished product; and
- WHEREAS, Christinia Thomas is employed by the Mille Lacs Band of Ojibwe as the Executive Director of the Office of Gaming Regulatory Authority and Compliance.
- NOW THEREFORE, BE IT RESOLVED, that the Band Assembly does hereby submit Ms. Christinia Thomas' name, as a nominee to the National Indian Gaming Commission on behalf of the Mille Lacs Band of Ojibwe to participate in this new MICS Advisory Committee .
- BE IT FURTHER RESOLVED, that Christinia Thomas is authorized to act in her official capacity on behalf of the Mille Lacs Band of Ojibwe relative to MICS Advisory Committee matters.
