A RESOLUTION AUTHORIZING A MODIFICATION IN THE LEGAL DESCRIPTION FOR THE CHARTER SCHOOL LEASE AGREEMENT BETWEEN THE MILLE LACS BAND OF OJIBWE INDIANS AND THE PINE GROVE LEADERSHIP ACADEMY AUTHRORIZED BY RESOLUTION # 12-03-90-07

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, any commercial activity, to acquire financing for a home or for any Educational Entity managed by non-band School Board; and
- WHEREAS, the original lease description for the Pine Grove Leadership Academy lease site was for approximately 2 acres more or less, which currently included the School Building and the Administration Building located on the attached map set forth as Exhibit A; and
- WHEREAS, Pine Grove Leadership Academy is requesting modification of their Charter School lease to remove the School Building from their existing legal description which is approximately 1 acre more or less; and
- WHEREAS, the new legal for the Charter School lease site is described as follows:

Part of Tract #410 TF 236, located in the East one-half (E ½) of the Northwest one-quarter of Section Ten (10), Township Forty-one (41) North, Range Seventeen (17) West, Fourth Principal Meridian, Pine County, Minnesota, further described as follows:

The leased area for the administration building Commences at Global Positioning System (GPS) coordinate (540,227.70; 5,099,881.90) thence North 45 degrees 23 minutes 42 seconds West a distance of 191.94 feet; thence North 41degrees 19 minutes 18 seconds East a distance of 185.70 feet; thence South 48 degrees 31 minutes 39 seconds East a distance of 193.63 feet; thence South 41 degrees 54 minutes 21 seconds East a distance of 196.20 feet to the point of beginning (GPS coordinates are Universal Transverse Mercator (UTM) Zone 15 NAD 83 Projection Points), approximately 1 acre more or less.

- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby authorizes the modification of the lease description by removing the School Building from the legal description; and
- BE IT FURTHER RESOLVED, that the new lease description is described above, subject to the lease provisions, effective upon date of approval and all other terms and conditions authorized by Resolution # 12-03-90-07 shall remain the same; and
- BE IT FURTHER AND FINALLY RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above-described property for more than thirty (30) consecutive days after the 1st year anniversary of the effective date of the lease without the prior approval of the Band Assembly; and
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 7th of February, 2008 at Vineland, Minnesota by a vote of 3 FOR, O AGAINST, O SILENT.
- IN WITNESS WHEREOF, we, the Band Assembly hereunto cause to have set the signature of the Speaker of the Assembly to be affixed to this resolution.
