JOINT RESOLUTION 13-03-29-09

A JOINT RESOLUTION APPROVING THE BLOOD QUANTUM INCREASE, BASED ON NEW ENROLLMENT ORDINANCE, SECTION VIII. B.

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe, and

WHEREAS, the Minnesota Chippewa Tribal Executive Committee has adopted a new Enrollment Ordinance by Resolution No. 116-03, passed July 30, 2003 at a regular meeting of the Tribal Executive Committee, and

WHEREAS, the Mille Lacs Band Assembly has reviewed the following documentation, and

WHEREAS, based on Enrollment Ordinance VIII. B. the blood quantum of Jennie Mitchell Door (Weyaus) will increase blood quantum from [REDACTED] and

WHEREAS, research has shown that her father James Door (Shaw ah bike to a/k/a Bah sqa gon) has a full sibling Mary Bigwind (kay bay nub equay) who is [REDACTED] on the 1941 Base Roll, and

WHEREAS, James Door died in 1938 so he was not included on 1941 Base Roll; and

WHEREAS, included for your review are letters from the family, family trees, copies of Annuity Rolls, enrollment cards, copies of the 1941 Base Roll.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly approves the above individual blood quantum increase, based on the new Enrollment Ordinance, Section VIII.B.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 22nd day of January, 2009 at Isle, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
