Joint Resolution 13-03-73-09

**A JOINT RESOLUTION APPOINTING TRIBAL LIAISONS TO
FORM A COMPLETE COUNT COMMITTEE TO ENSURE
AN ACCURATE COUNT OF BAND MEMBERS AND
OTHER INDIANS LIVING ON BAND LANDS
AS ONE OF THE CORE STRATEGIES OF THE 2010 U.S. CENSUS**

WHEREAS, the Mille Lacs Band of Ojibwe Band Assembly is the duly elected and federally recognized governing body for the Mille Lacs Reservation; and

WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and

WHEREAS, the U.S. Constitution requires a national census of the U.S. population and housing unit every 10 years; and

WHEREAS, federal agencies recognize the importance of the government-to-government relationship with federally recognized tribal governments; and

WHEREAS, the U.S. Census Bureau's goal is to get an accurate count on tribal lands on April 1, 2010 for the purpose of assessing the amount of federal funds to be awarded to tribes, states and other communities; and

WHEREAS, one of the core strategies for **Census 2010** is partnership building through the establishment of the Tribal Government Liaison Program; and

WHEREAS, the Mille Lacs Band of Ojibwe wishes to participate in partnership building with the U.S. Census Bureau and appoints Mike Moilanen, Planner, and Lisa Johnson, Realty Director, as Tribal Liaisons to coordinate outreach efforts in partnership with the U.S. Census Bureau.

NOW THEREFORE BE IT RESOLVED, that the Mille Lacs Band of Ojibwe hereby appoints **Mike Moilanen** and **Lisa Johnson** as Tribal Liaisons to form a Complete Count Committee representing the Mille Lacs Band of Ojibwe; and that tribal staff work with the U.S. Census Bureau to promote a complete population count on the Mille Lacs Reservation.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 4th of June, 2009 at Hinckley, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.


