
A JOINT RESOLUTION APPROVING THE SUBMISSION OF 2009 INDIAN COMMUNITY DEVELOPMENT BLOCK GRANT APPLICATION TO THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT TO HELP FUND THE CONSTRUCTION OF AN EARLY EDUCATION FACILITY ON SITE T001037 OF OUR TRUST LANDS

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Mille Lacs Band Assembly has established as a priority the improvement of the social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Mille Lacs Band Assembly recognizes that there is an urgent need to remove Early Education services from our tribal schools into a separate facility as required by the Bureau of Indian Education; and
- WHEREAS, the Mille Lacs Band of Ojibwe approves trust land site T001037 as the potential location for an Early Education facility.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly and Chief Executive do hereby authorize and approve of Trust Land Site T001037 as the potential location for an Early Education facility.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 21st day of July, 2009 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
