**JOINT RESOLUTION 13-04-93-09**

**A JOINT RESOLUTION APPROVING THE SUBMISSION OF A 2009 TRIBAL ECONOMIC DEVELOPMENT BOND APPLICATION TO THE U.S. DEPT. OF TREASURY FOR \$3.5 MILLION TO FUND THE CONSTRUCTION OF DAYCARE FACILITIES IN DISTRICTS I, II and III.**

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Mille Lacs Band Assembly has established as a priority the improvement of the social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Mille Lacs Band Assembly recognizes that there is a urgent need for daycare facilities in Districts I, II and III and this is reflected by the long waiting list at the current small daycare facility in District I; and
- WHEREAS, the Mille Lacs Band Assembly also recognize that a daycare facility in each district would assist parents who wish to become employed and/or those who are currently employed; and
- WHEREAS, the Mille Lacs Band of Ojibwe fully supports the goals of the Recovery Act for job creation and to provide infrastructure that will provide long term economic benefits; and
- WHEREAS, the Mille Lacs Band of Ojibwe will not use any of the funds from the Tribal Economic Development Bonds for gaming.
- NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly and Chief Executive hereby authorize and approve the submission of a bonding application to the U.S. Dept. of Treasury to fund the construction of daycare facilities in Districts I, II and III.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 13<sup>th</sup> day of August, 2009 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.


