RESOLUTION 13-03-58-09

**A RESOLUTION RESCINDING RESOLUTION # 13-02-61-08
AUTHORIZING A RESIDENTIAL LAND LEASE TO [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home, and

WHEREAS, Resolution #13-02-61-08, authorized a residential land lease for [REDACTED] and [REDACTED]

WHEREAS, the residential lease was to be for a period of 25 years and renewable for an additional 25 years, and was subject to the lease provisions, effective upon date of approval; and

WHEREAS, said land is described as follows:

Part of Tract 410 T 116 located in the West one half of the Southeast one quarter of the Southwest one quarter of the Southeast one quarter (W1/2SE1/4SW1/4SE1/4) of Section Seventeen (17), Township Forty-three North (T43N), Range Twenty-seven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota.

More particularly described as Follows: Lot Four (4), Bugg Hill Trailer Park Plat.

WHEREAS, the Lessee wishes to relinquish this lease due to non-use of the site; and

WHEREAS, the Lessee has signed a document requesting relinquishment of Resolution # 13-02-61-08 (attached as Exhibit A and therefore made a part of this resolution).

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the rescinding of Band Resolution #13-02-61-08; and


