**A JOINT RESOLUTION OF THE MILLE LACS BAND OF
OJIBWE APPROVING THE DEPARTMENT OF ATHLETIC
REGULATION BOXING COMMISSION LOGO**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe; and

WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and

WHEREAS, Chapter 2 of Title 15 of the Mille Lacs Band Statutes Annotated ("MLBSA") was enacted to create the Department of Athletic Regulation ("DAR") Boxing Commission for the purpose of regulating all professional athletic events on Band land; and

WHEREAS, the Boxing Commissioners created and approved the use of the logo which is attached hereto as **Exhibit A** to use on its clothing, boxing merchandise, stationery, and on the Band website; and

WHEREAS, the Band Assembly and Chief Executive have reviewed the logo and find that it is in the best interest of the Mille Lacs Band of Ojibwe to approve the DAR Boxing Commission's logo to use on its clothing, boxing merchandise, stationery, business cards and on the Band website.

NOW THEREFORE BE IT RESOLVED, that the Band Assembly and Chief Executive have approved the use of the DAR logo by the Boxing Commission on its clothing, boxing merchandise, stationery, business cards and on the Band website.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 13th day of February, 2009, at Hinckley, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
