JOINT RESOLUTION 13-04-111-09

A JOINT RESOLUTION TO APPROVE THE VARIANCE REQUEST(S) FOR DROP-IN CHILD CARE CENTERS LOCATED AT GRAND CASINO MILLE LACS AND GRAND CASINO HINCKLEY

- WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe, a Federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly is empowered by Band Statue 3 MLBSA § 2, to adopt resolutions which promote the general welfare of the Mille Lacs Band and its members; and
- WHEREAS, on August 25, 2009, the Band Assembly and Chief Executive approved the license application of Amy K. Bohlman, President, and Alan Bohlman, of AB Bohlman, Inc. to operate Drop-In Child Care Centers to be located at Grand Casino Mille Lacs and Grand Casino Hinckley through Joint Resolution 13-04-97-09; and
- WHEREAS, the Band Assembly and Chief Executive acknowledge that a need exists to allow the proposed Drop-In Child Care Centers to allow a child to attend the center for more than 90 hours in a month; and
- WHEREAS, the owners and operators of AB Bohlman, Inc. have requested a variance to allow children to attend the center for more than 90 hours in a month at both Grand Casino locations; and
- WHEREAS, the Band Assembly and Chief Executive believe that approval of the variance would be in the best interest of the Band.

NOW THEREFORE BE IT RESOLVED, the variance request(s) of AB Bohlman, Inc. to allow children to attend the Drop-In Child Care Centers to be located at Grand Casino Mille Lacs and Grand Casino Hinckley for more than 90 hours per month is hereby approved.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly adopted at a regular session of the Band Assembly in Legislative Council, a quorum of legislators being present held on the 23rd day of September, 2009 at Hinckley, Minnesota by a vote of __2FOR, ___AGAINST, ___SILENT.
