## **RESOLUTION 13-03-56-09**

## A RESOLUTION RESCINDING RESOLUTION # 13-01-35-08 AUTHORIZING A RESIDENTIAL LAND LEASE WITH AN ATTACHED MORTGAGE FOR

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe WHEREAS. for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home, and

WHEREAS. Resolution #13-01-35-08, authorized a residential land lease with an attached mortgage to be given to

the residential lease was to be for a period of 35 years and renewable for an WHEREAS. additional 15 years, and was subject to the lease provisions, effective upon date of approval; and

said land is described as follows: WHEREAS,

> Part of Tract 410 TF 102 located in part of Government Lot 2, Section Thirty-one (31), Township Forty-four North (T44N), Range Twenty-seven West (27W) Crow Wing County, Fourth Principal Meridian, more particularly described as follows:

Commencing at the southwest corner of Outlot A, Port Mille Lacs Holiday Harbor, according to the recorded plat thereof, said Crow Wing County, thence North 74 degrees 26 minutes 33 seconds East, assumed bearing along the south line of said Outlot A and the south line of Lot 1, Block 2, said Port Mille Lacs Holiday Harbor, a distance of 80.00 feet; thence South 15 degrees 33 minutes 27 seconds East, a distance of 10.00 feet to the point of beginning of said tract of land to be described; thence North 74 degrees 26 minutes 33 seconds East, parallel with said south line of Lot 1, Block 2, a distance of 200.00 feet; thence South 15 degrees 33 minutes 27 seconds East, a distance of 200.00 feet; thence South 74 degrees 26 minutes 33 seconds West a distance of 200.00 feet; thence North 15 degrees 33 minutes 27 seconds West, a distance of 200.00 feet to the point of beginning. This lease site is 1 acre more or less; and

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 20th of April, 2009 at Hinckley, Minnesota by a vote of 2\_FOR, \_0\_AGAINST, \_0\_SILENT.
