**A JOINT RESOLUTION APPROVING THE SUBMISSION OF A MN  
COMMUNITY ACTION GRANT TO THE MN DEPARTMENT OF HEALTH  
AND HUMAN SERVICES TO HELP FUND THE MILLE LACS RESERVATION  
COMMUNITY RECREATION AND SPORTS PROGRAMS**

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Mille Lacs Band of Ojibwe has established as a priority the improvement of the social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Mille Lacs Band of Ojibwe recognizes the importance of providing activities that promote a healthy and culturally enriched lifestyle to its community, particularly Band members in economic disparity, or the elderly; and
- WHEREAS, the Mille Lacs Band of Ojibwe fully supports the goals of the Minnesota Department of Health and Human Services to significantly decrease the effects of poverty by offering service to those in need; and
- WHEREAS, the Mille Lacs Band of Ojibwe recognizes the importance of providing services and activities that will encourage and prepare members to be self sufficient.

NOW THEREFORE BE IT RESOLVED, the Mille Lacs Band of Ojibwe hereby authorizes and supports the submission of a Minnesota Community Action Grant to the MN Department of Health and Human Services, to help fund the Mille Lacs Reservation Community Recreation and Sports Programs.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 7<sup>th</sup> day of May, 2009 at Isle, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
