JOINT RESOLUTION 13-04-110-09

A RESOLUTION TO APPROVE THE SIGNING OF THE MULTIYEAR FUNDING AGREEMENT WITH THE INDIAN HEALTH SERVICE.

- WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe; a Federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly is empowered by Band Statute 3 MLBSA § 2, to adopt Resolutions which promote the general welfare of the Mille Lacs Band and its members; and
- WHEREAS, in 1991, the Mille Lacs Band entered into the Self-Governance Demonstration Project, pursuant to Title III of Public Law 93-638, as amended by Public Law 102-184; and
- WHEREAS, the Mille Lacs Band continued with the Self-Governance program as it became a permanent Tribal option within the Department of Health and Human Services as authorized by P.L. 93-638, Title V, "The Tribal Self-Governance Act of 2000"; and
- WHEREAS, successful Self-Governance for the Mille Lacs Band is of the most immediate importance to the perpetuation of the Mille Lacs Band of Ojibwe.

NOW THEREFORE BE IT RESOLVED, the 2010-2012 Multiyear Funding Agreement between the Mille Lacs Band of Ojibwe and the Department of Health and Human Service, Indian Health Service is hereby approved.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly adopted at a regular session of the Band Assembly in Legislative Council, a quorum of legislators being present held on the 23rd day of September, 2009 at Hinckley, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
