## **RESOLUTION 13-03-39-09**

## A RESOLUTION AUTHORIZING A RESIDENTIAL LAND LEASE WITH AN ATTACHED MORTGAGE FOR

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe WHEREAS, for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- respectfully request a land lease for residential WHEREAS. purposes; and
- has been approved for financing from the Mille Lacs WHEREAS. Band of Ojibwe Housing Department for the purpose of a home located on the subject property; and
- WHEREAS, the lease will be for a period of 35 years and renewable for an additional 15 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- said land is described as follows: WHEREAS, Part of Tract # 410 TF 108, located in the North half of the Northwest Quarter (N1/2NW1/4) of Section Twenty (20), Township Forty-three North (43N), Range Twenty-seven West (27W), Fourth Principal Meridian, Mille Lacs County, Minnesota, described as follows:

Lot One (1) Block Two (2) of Bugg Hill West Plat.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby authorizes a land lease with an attached mortgage for the property described herein for residential purposes be issued to period of 35 years, renewable for an additional 15 years subject to the lease provisions, effective upon date of approval; and

- BE IT FURTHER RESOLVED, that the lessors will utilize the land in conformity with the provisions of the lease within twelve (12) months of the effective date of the lease, and if all terms of the lease are not met, the land will revert to the Mille Lacs Band of Ojibwe; and
- BE IT FURTHER RESOLVED, that this lease shall be null and void should the lessors abandon or vacate the above-described property for more than thirty (30) consecutive days after the 1<sup>st</sup> year anniversary of the effective date of the lease without the prior approval of the Band Assembly; and
- BE IT FURTHER AND FINALLY RESOLVED, that this will terminate any other residential lease agreement that may be in existence in the name of the lessor.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 3rd of March, 2009 at Isle, Minnesota by a vote of 3 FOR, AGAINST, SILENT.
