
A JOINT RESOLUTION APPROVING THE SUBMISSION OF A 2009 TRIBAL ECONOMIC DEVELOPMENT BOND APPLICATION TO FUND THE CONSTRUCTION OF AN EARLY EDUCATION FACILITY ON SITE T0001037 OF OUR TRUST LANDS

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Mille Lacs Band Assembly has established as a priority the improvement of the social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Mille Lacs Band Assembly recognizes there is an urgent need to remove Early Education services from our schools to get them housed in their own facility as required by the Bureau of Indian Education; and
- WHEREAS, the Mille Lacs Band of Ojibwe approves trust land site T0001037 as the potential location for an Early Education facility.

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly and Chief Executive hereby authorize and approve the submission of a 2009 Tribal Economic Bond application to fund the construction of an Early Education Facility on site T0001037 of our trust lands.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 12th day of August, 2009 at Isle, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
