JOINT RESOLUTION 13-03-69-09

A JOINT RESOLUTION APPROVING THE LETTER OF CONSENT ALLOWING THE BOARD OF BARBERS AND COSMETOLOGIST EXAMINERS TO EXECUTE ITS DUTIES UNDER STATE LAW ON THE RESERVATION

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe ("the Band"); and
- WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, a priority of the Band Assembly is to provide for the financial well being and welfare of the Band; and
- WHEREAS, the Band's Corporate Commission have proposed a hair salon at Grand Casino Mille Lacs and established a spa & salon business at Grand Casino Hinckley; and
- WHEREAS, in order to protect the state licensure of future employees of these businesses, it is necessary to allow the Minnesota Board of Barbers and Cosmetologist Examiners (the "Board") to come on the Reservation and execute its duties under state law; and
- WHEREAS, the Band Assembly and Chief Executive believe it is in the Band's best interest to grant permission to the Board to execute its duties under state law, so as to allow employees of the proposed businesses to work without fear of jeopardizing their state licenses.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly and Chief Executive do approve the Letter of Consent and its authorization for the Minnesota Board of Barbers and Cosmetologist Examiners to inspect the salon and spa businesses of the Mille Lacs Band of Ojibwe.
- WE DO HEREBY CERTIFY, that the foregoing Resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 28th day of April, 2009 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
