JOINT RESOLUTION 13-04-100-09

A JOINT RESOLUTION SUPPORTING THE APPROVAL OF THE INTEGRATED RESOURCE MANAGEMENT PLAN (IRMP) FOR 2009-2019.

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, the IRMP enhances Tribal self-governance, Tribal resource management and protection of Tribally important areas and resources; and

WHEREAS, The Mille Lacs Band of Ojibwe and other Tribal, Federal, state and non-governmental agencies do benefit from working together on local and regional environmental projects and resource management activities; and


WHEREAS, the IRMP will satisfy the 25 CFR 163 requirements which will make available expenditures of BIA funds or grants; and

WHEREAS, the Mille Lacs Band Department of Natural Resources/Environment will review the IRMP on an annual basis to update and improve the IRM as needed.


NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby approves the Integrated Resource Management Plan as presented and concurs with the recommended or preferred alternatives as presented by the Department of Natural Resource/Environment.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 22nd day of October, 2009 at Hinckley, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
