RESOLUTION 13-03-53-09


A RESOLUTION APPROVING THE SUBMISSION OF A \$431,312.00 FEDERAL GRANT TO THE U.S. DEPT. OF JUSTICE COPS HIRING AND REINVESTMENT PROGRAM (CHRP) TO HELP FUND THE MILLE LACS BAND'S TRIBAL POLICE DEPARTMENT.

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Mille Lacs Band Assembly has established as a priority to improve the social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Mille Lacs Band Assembly recognizes the importance of providing professional law enforcement service and crime prevention efforts; and
- WHEREAS, the Mille Lacs Band of Ojibwe fully supports the goals of the United States Department of Justice to improve law enforcement service in Indian country; and
- WHEREAS, Mille Lacs Band Assembly recognizes how the Mille Lacs Band's Department of Public Safety and Tribal Police requests funding through this grant program to supplement law enforcement sworn officer positions.

NOW THEREFORE BE IT RESOLVED, the Mille Lacs Band Assembly does hereby authorize and approve the submission of a CHRP grant to the Department of Justice for the purpose of obtaining supplemental Federal funding for 2 additional sworn police officer positions for 4 years (1 year locally funded retention).

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 7th day of April, 2009 at Hinckley, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
