
JOINT RESOLUTION 13-04-87-09

A JOINT RESOLUTION APPROVING THE SUBMISSION OF A 2009 INDIAN COMMUNITY DEVELOPMENT BLOCK GRANT TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT TO FUND THE CONSTRUCTION OF AN EARLY EDUCATION FACILITY.

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Mille Lacs Band Assembly has established as a priority the improvement of the social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Mille Lacs Band Assembly recognizes the importance of providing access to child care and early education services to those in need; and
- WHEREAS, the Mille Lacs Band of Ojibwe fully supports the goals of the Recovery Act for job creation and to provide infrastructure that will provide long-term economic benefits; and
- WHEREAS, the Mille Lacs Band of Ojibwe is committed to funding the remaining balance of the project to construct an Early Education facility beyond the Indian Community Development Block Grant award and all cooperating awards.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly and Chief Executive do hereby authorize and approve the submission of a grant to the U.S. Department of Housing and Urban Development for funding to construct and Early Education facility.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 21st day of July, 2009 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
