JOINT RESOLUTION 13-03-68-09

A JOINT RESOLUTION APPROVING THE BLOOD QUANTUM INCREASE, BASED ON NEW ENROLLMENT ORDINANCE, SECTION VIII. B.

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe, and

WHEREAS, the Minnesota Chippewa Tribal Executive Committee has adopted a new Enrollment Ordinance by Resolution No. 116-03, passed July 30, 2003 at a regular meeting of the Tribal Executive Committee, and

WHEREAS, the Mille Lacs Band Assembly has reviewed the following documentation, and

WHEREAS, based on Enrollment Ordinance VIII. B. the blood quantum of:

WHEREAS, Jennie Weyaus Mitchell will increase from [REDACTED] and the remaining siblings will increase from [REDACTED]; and

WHEREAS, due to their full sibling [REDACTED] being listed as [REDACTED] on the 1910 Blood Roll. [REDACTED] died before the 1941 Base Roll, and

WHEREAS, this family was researched by the ERC committee as part of the appeals process, which included for review, are copies of the 1910 Blood Roll, copies of the 1941 Base Roll, birth certificates, enrollment cards, family sheets and a letter from the family.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly approves the above individual's blood quantum increase, based on the new Enrollment Ordinance, Section VIII.B.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 23rd day of April, 2009 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.


