RESOLUTION 13-03-67-09

A RESOLUȚION AUTHORIZING A LAND LEASE FOR RESIDENTIAL PURPOSES TO

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, respectfully requests a land lease for Residential purposes; and

WHEREAS, the lease will be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and

WHEREAS, said land is described as follows:

Part of Tract 410 TF 222 located in the Northwest quarter (NW1/4), the Southwest quarter of the Northeast quarter (SW1/4 of NE1/4), the East half of the Southwest quarter (E1/2 of SW1/4), the Southeast quarter (SE1/4), the Southeast quarter of the Northeast quarter (SE1/4 of NE1/4), and the North half of the Northeast quarter (N1/2 of NE1/4), all in Section Two (2), Township Forty-one North (T41N), Range Twenty West (R20W). Fourth Principal Meridian, Pine County, Minnesota.

Described as follows: Beginning at a Global Positioning System (GPS) Coordinate (513,343.969631; 5,100,165.978207) thence bearing North 0 degrees 03 minutes 57 seconds West a distance of 517.25 feet, thence South 89 degrees 59 minutes 58 seconds East a distance of 136.28 feet, thence South 0 degrees 52 minutes 32 seconds East a distance of 516.27 feet, thence South 89 degrees 35 minutes 16 seconds west a distance of 143.58 feet to GPS Coordinate (513,343.969631; 5,100,165.978207), to the point of beginning (GPS Coordinates are Universal Transverse Mercator (UTM) Zone 15 NAD 83 Projection Points). This lease site is 1 acre more or less.

- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby authorizes a land lease for the property described herein for residential purposes be issued to for an additional 25 years subject to the lease provisions, effective upon date of approval; and
- BE IT FURTHER RESOLVED, that the lessee will utilize the land in conformity with the provisions of the lease within twelve (12) months of the effective date of the lease, and if all terms of the lease are not met, the land will revert to the Mille Lacs Band of Ojibwe; and
- BE IT FURTHER RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above-described property for more than thirty (30) consecutive days after the 1st year anniversary of the effective date of the lease without the prior approval of the Band Assembly.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 28th of April, at Vineland, Minnesota by a vote of _3 FOR, 0 AGAINST, 0 SILENT.
