JOINT RESOLUTION 13-03-54-09

A JOINT RESOLUTION IN SUPPORT OF THE MINNESOTA INDIAN GAMING ASSOCIATION'S (MIGA) ENDEAVOR TO SOLICIT THE U.S. GOVERNMENT TO ENACT LEGISLATION THAT WOULD AMEND THE NATIONAL LABOR RELATIONS ACT (NLRA) TO RECOGNIZE THAT INDIAN TRIBES SHOULD BE TREATED AS GOVERNMENTS

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Chief Executive is empowered to exercise all executive political authority for the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Mille Lacs Band of Ojibwe is one of the nine (9) federally-recognized Indian Tribes in Minnesota that holds membership in the Minnesota Indian Gaming Association (MIGA); and
- WHEREAS, an exercise of the inherent sovereign authority of the Mille Lacs Band of Ojibwe is the operation of gaming on trust land within its territorial lands and as recognized by the federal government under the Indian Gaming Regulatory Act (IGRA) (25 U.S.C. § 2701 et seq.); and
- WHEREAS, the inherent sovereign authority of the Mille Lacs Band of Ojibwe within its territory is confirmed in its Treaties with the United States and the principles outlined therein that confirm the Tribe's right to determine the conditions under which others are permitted to enter Tribal lands; and
- WHEREAS, the Mille Lacs Band of Ojibwe believes that the National Labor Relations Board (NLRB) has improperly held that the National Labor Relations Act (NLRA) applies to Tribal governments that conduct gaming on its reservations; and
- WHEREAS, the United States government has a treaty-based obligation to protect the sovereignty of Indian Tribes on those lands that are set aside for the use and occupancy of Indian Tribes; and
- WHEREAS, the Mille Lacs Band of Ojibwe supports the Minnesota Indian Gaming Association (MIGA) efforts to enlist the United States government to amend the National Labor Relations Act (NLRA) to recognize that Indian Tribes are to be treated as governments.
