**JOINT RESOLUTION 13-04-95-09**


**A JOINT RESOLUTION APPROVING THE SUBMISSION OF A 2009 TRIBAL ECONOMIC DEVELOPMENT BOND APPLICATION TO THE U.S. DEPARTMENT OF TREASURY FOR \$8,348,374.00 IN TREASURY BONDS TO FUND THE CONSTRUCTION OF AN EARLY EDUCATION FACILITY ON OUR RESERVATION**

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Mille Lacs Band Assembly has established as a priority the improvement of the social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Mille Lacs Band Assembly recognizes the importance of providing access to child care and early education services to those in need; and
- WHEREAS, the Mille Lacs Band of Ojibwe fully supports the goals of the Recovery Act, for job creation and to provide infrastructure that will provide long-term economic prosperity
- WHEREAS, the Mille Lacs Band of Ojibwe will not use any of the Tribal Economic Development Bonds for gaming; and
- WHEREAS, the Mille Lacs Band of Ojibwe will apply funds from the Tribal Economic Development Bonds for the construction of an Early Education Facility on the Mille Lacs Reservation.

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly and Chief Executive hereby authorize and approve the submission of a grant to the U.S. Department of Treasury.

WE DO HEREBY CERTIFY, that the foregoing joint resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 12<sup>th</sup> day of August, 2009 at Isle, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
