JOINT RESOLUTION 13-03-38-09

A JOINT RESOLUTION APPROVING A NEW E-MAIL DOMAIN NAME CHANGE FOR THE MILLE LACS BAND OF OJIBWE TRIBAL GOVERNMENT

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the I.S. department will be taking on the e-mail function for the Mille Lacs Band of Ojibwe Tribal Government; and
- WHEREAS, the e-mail system of Group Wise and "nsn.us" are a decade old and the I.S. department is changing to the updated Microsoft Exchange Server that will house both internal, and external e-mail (through the Microsoft Outlook program); and
- WHEREAS, the e-mail "@millelacsojibwe.nsn.us" is not owned by the Mille Lacs Band of Ojibwe, and by changing to "@millelacsojibwe.com", the Band will own the e-mail domain.

NOW THEREFORE BE IT RESOLVED, that the Band Assembly and Chief Executive have approved changing the e-mail domain name.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 19th day of February, 2009, at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
