**A JOINT RESOLUTION APPROVING THE SUBMISSION OF
A FAMILY DRUG COURTS PROGRAM GRANT APPLICATION
TO THE U.S. DEPARTMENT OF JUSTICE: OFFICE OF JUVENILE JUSTICE
DELINQUENCY PREVENTION ("OJJDP") TO FUND THE DEVELOPMENT
OF THE MILLE LACS BAND OF OJIBWE FAMILY DRUG COURTS
PROGRAM**

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Mille Lacs Band Assembly has established as a priority the improvement of the social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Mille Lacs Band Assembly recognizes the importance of providing access to a Family Drug Courts Program as part of the Mille Lacs Band of Ojibwe government; and
- WHEREAS, the Mille Lacs Band of Ojibwe fully supports the goals of the U.S. Department of Justice: Office of Juvenile Justice Delinquency Prevention ("OJJDP") to provide national leadership, coordination, and resources to prevent and respond to juvenile delinquency and victimization.

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly and Chief Executive hereby authorize and approve the submission of a grant application to the U.S. Department of Justice: Office of Juvenile Justice Delinquency Prevention ("OJJDP") for the purpose of establishing a Family Drug Courts Program within the Mille Lacs Band of Ojibwe government.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 9th day of June, 2009 at Carlton, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
