**JOINT RESOLUTION 14-02-19-10**

**A JOINT RESOLUTION APPROVING THE SUBMISSION OF A CHILDREN'S MENTAL HEALTH DIVISION GRANT TO THE MINNESOTA DEPARTMENT OF HUMAN SERVICES TO HELP FUND THE MILLE LACS BAND OF OJIBWE BEHAVIORAL HEALTH DEPARTMENT**

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Mille Lacs Band Assembly has established as a priority the improvement of the social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Mille Lacs Band Assembly recognizes the importance of providing access to improve the availability of our mental health professionals for preventative services and treatment of behavioral issues as well as increasing the number of Native American mental health professionals in Behavioral Health Services; and
- WHEREAS, the Mille Lacs Band of Ojibwe fully supports increasing the availability of mental health services for children from cultural and ethnic minorities and to help members of cultural and ethnic minorities to become qualified mental health professionals and clinical supervisors and
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly does hereby authorize and approve the submission of a grant to the Minnesota Department of Human Services for the purpose of increasing the availability of mental health services to children from cultural and ethnic minorities and to help members of cultural and ethnic minorities to become qualified mental health professionals and clinical supervisors.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 22nd day of September 2010 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
