RESOLUTION 13-04-23-10

**A RESOLUTION TO CANCEL LEASE AUTHORIZED BY
RESOLUTIONS #06-01-54-94 & 05-03-55-93 FOR [REDACTED]
[REDACTED] NON-BAND MEMBER**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolutions #06-01-54-94 & 05-03-55-93, authorized a lease to be given to [REDACTED] for the purpose of obtaining a leasesite; and

WHEREAS, the lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and

WHEREAS, said land is described as follows:
Beginning at the Southwest corner of the SW1/4 of NW ¼, thence 77.8 ft. North, thence 650 ft. East, thence 40 ft. South to the point of beginning, thence 330.0 ft. North, thence 100 ft. West, thence 273 ft. South, thence running Southeasterly (approximately 102 ft.) parallel with road to point of beginning in Section Twenty-seven (27), Township Forty-three North (43N), Range Twenty-seven West (27W), on Mille Lacs Reservation, Fourth Principal Meridian, Mille Lacs County, Minnesota, Vineland Hills, Allotment A-75. This lease site is 1 acre more or less; and

WHEREAS, [REDACTED] is a non-band member and no longer resides at this residence; and

WHEREAS, the house is no longer standing due to a fire.

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby approves the Cancellation of the lease authorized by Band Resolutions #06-01-54-94 & 05-03-55-93; and
