JOINT RESOLUTION 14-01-77-10

A JOINT RESOLUTION DESIGNATING MORGAN STANLEY SMITH BARNEY LLC. AS DEPOSITORY FOR APRIL 2010 DISTRIBUTION-MINOR TRUST ACCOUNT.

WHEREAS, the Mille Lacs Band Assembly is a duly elected governing body of the Mille Lacs Band of Ojibwe, a Federally-recognized Indian Tribe; and

WHEREAS, the Mille Lacs Band Assembly is empowered by 3 MLBSA Sub. Section 2 to adopt resolutions which promote the general welfare of the people; and

WHEREAS, the Mille Lacs Band Assembly has approved the accounts of specifically appropriated funds to the investment firm of Morgan Stanley Smith Barney LLC.

NOW THEREFORE BE IT RESOLVED, that the Morgan Stanley Smith Barney LLC. is designated as a depository for the minor trust funds of the Mille Lacs Band of Ojibwe; and

- (1) This resolution shall continue to have effect until express written notice of its rescission or modification has been received and recorded by Morgan Stanley Smith Barney LLC.
- (2) All transactions, if any, with respect to any deposit, withdrawals, by or on behalf of the Mille Lacs Band with Morgan Stanley Smith Barney LLC. prior to the adoption of this resolution are hereby ratified, approved and confirmed.
- (3) Any 2 of the 3 persons named below, so long as they act in a representative capacity as agents of the Mille Lacs Band, are authorized to make any and all other contracts, agreements, stipulations and orders which they may deem advisable for the effective exercise of the powers indicated below, from time to time with Morgan Stanley Smith Barney LLC. concerning funds deposited in Morgan Stanley Smith Barney LLC. or any other Business transacted by and between the Mille Lacs Band and Morgan Stanley Smith Barney LLC. subject to any restrictions stated below.
- (4) Any and all prior resolutions adopted by the Mille Lacs Band and certified to Morgan Stanley Smith Barney LLC. as governing the operation of the Mille Lacs Band's account(s) are in full force and effect, unless supplemented or modified by this authorization.


