## **RESOLUTION 14-02-24-10**

## A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED BY RESOLUTION #85-81 A FOR

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution #85-81 A, authorized a lease to be given to for the purpose of obtaining a leasesite; and
- WHEREAS, the land lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, said land is described as follows:

Part of Tract 410 T 1017 located in the Northeast quarter of the Northwest quarter (NE1/4NW1/4) of Section Seventeen (17), Township Forty-seven North (T47N), Range Twenty-three West (R23W), Fourth Principal Meridian, Aitkin County, Minnesota.

More particularly described as Follows: Lot One (1) and Lot Two (2), This lease site is 1 acre more or less.

- WHEREAS, Ms Shingobe is deceased (date of death April 18, 2004).
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the cancellation of the land lease authorized by Band Resolution #85-81 A; and

BE IT FURTHER RESOLVED, that the land will revert to the Mille Lacs Band of Ojibwe for lease to another Band member.
