JOINT RESOLUTION 13-04-01-10

A JOINT RESOLUTION CORRECTING DROP-IN CHILD CARE CENTER LICENSEE NAME CHANGE FROM AB BOHLMAN, INC. TO **BOHLMAN, INCORPORATED**

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, on August 25, 2009, Joint Resolution 13-04-97-09 was adopted by the Band Assembly approving the license application of Amy K. Bohlman, President, and Alan Bohlman, of AB Bohlman, Inc. to operate drop-in child care centers at Grand Casino Hinckley and Grand Casino Mille Lacs; and
- WHEREAS, on September 23, 2009, Joint Resolution 13-04-111-09 was adopted by the Band Assembly approving the variance request(s) allowing a child to attend the drop-in child care center for more than 90 hours in a month; and
- WHEREAS, a name for the drop-in child care centers has been formulated and both centers shall be referred to as "Grand Venture for Kids;" and
- WHEREAS, the Band Assembly acknowledges that owners, Amy K. Bohlman and Alan Bohlman, have formed a new corporation under the name of Bohlman, Incorporated for the purpose of operating the drop-in child care centers at Grand Casino Hinckley and Grand Casino Mille Lacs; and
- WHEREAS, the Band Assembly further acknowledges that the name of the licensing entity on Joint Resolution(s) 13-04-97-09 and 13-04-111-09 are changed from AB Bohlman, Inc. to Bohlman, Incorporated.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band of Ojibwe hereby acknowledges the name change of the licensing entity from AB Bohlman, Inc. to Bohlman, Incorporated and approves Bohlman, Incorporated as the entity that will operate the drop-in child care centers at Grand Casino Hinckley and Grand Casino Mille Lacs known as "Grand Venture for Kids."
