RESOLUTION 14-02-24-10

A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED BY RESOLUTION #85-81 A FOR [REDACTED]

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution #85-81 A, authorized a lease to be given to [REDACTED] for the purpose of obtaining a leasesite; and

WHEREAS, the land lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and

WHEREAS, said land is described as follows:

Part of Tract 410 T 1017 located in the Northeast quarter of the Northwest quarter (NE1/4NW1/4) of Section Seventeen (17), Township Forty-seven North (T47N), Range Twenty-three West (R23W), Fourth Principal Meridian, Aitkin County, Minnesota.

More particularly described as Follows: Lot One (1) and Lot Two (2), This lease site is 1 acre more or less.

WHEREAS, Ms Shingobe is deceased (date of death April 18, 2004).

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the cancellation of the land lease authorized by Band Resolution #85-81 A; and

BE IT FURTHER RESOLVED, that the land will revert to the Mille Lacs Band of Ojibwe for lease to another Band member.
