#### JOINT RESOLUTION 14-01-135-10

# A JOINT RESOLUTION DESIGNATING WOODLANDS NATIONAL BANK AS DEPOSITORY

- the Mille Lacs Band Assembly is the duly elected governing body of the Mille WHEREAS, Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- the Mille Lacs Band Assembly is empowered by 3 MLBSA § 2(d) to adopt WHEREAS, resolutions which promote the general welfare of the people; and
- the Chief Executive is the duly elected Executive Officer for the Mille Lacs Band WHEREAS, of Ojibwe and is empowered to exercise the Executive Branch powers; and
- the Mille Lacs Band Assembly has approved the accounts of specifically WHEREAS, appropriated funds as shown hereinbelow to Woodlands National Bank.
- NOW THEREFORE BE IT RESOLVED, that Woodlands National Bank is designated as a depository for the Mille Lacs Band of Ojibwe Indians; and
  - (2) This resolution shall continue to have effect until express written notice of its rescission or modification has been received and recorded by Woodlands National Bank.
  - (3) All transactions, if any, with respect to any deposit, withdrawals, rediscounts and borrowings by or on behalf of the Mille Lacs Band with Woodlands National Bank prior to the adoption of this resolution are hereby ratified, approved and confirmed.
  - (4) Any of the persons named below, so long as they act in a representative capacity as officials of the Mille Lacs Band, are authorized to make any and all other contracts, agreements, stipulations and orders which they may deem advisable for the effective exercise of the powers indicated below, from time to time with Woodlands National Bank concerning funds deposited in Woodlands National Bank or any other Business transacted by and between the Mille Lacs Band and Woodlands National Bank subject to any restrictions stated below.
  - (5) Any and all prior resolutions adopted by the Mille Lacs Band and certified to Woodlands National Bank as governing the operation of the Mille Lacs Band's account(s) are in full force and effect, unless supplemented or modified by this authorization.



(6) The Mille Lacs Band agrees to the terms and conditions of any account agreement, properly opened by any authorized officials of the Mille Lacs Band, and authorizes Woodlands National Bank named above, at any time, to charge the Mille Lacs Band for all checks, drafts, or other orders, for the payment of money, that are drawn on this Financial Institution regardless of by whom or by what means the facsimile signature(s) may have been affixed as long as they resemble the facsimile signature specimens in section C, (or the facsimile signature specimens that the Mille Lacs Band files with Woodlands National Bank from time to time) and contain the required number of signatures for this purpose.

(1) Open any deposit or checking account(s) in the name of the Mille Lacs Band.

(2) Transfer, convert, endorse, buy, sell, assign, set over and deliver any and all shares of bonds, debentures, notes, or other securities now or hereafter standing in the name of or owned by the Band or to make, execute and deliver, under the seal of the Band, any and all written instruments of assignment and transfer necessary or proper to effectuate hereby conferred. Securities cannot be used as colleratal. Number of authorized signatures required for this purpose

#### Secretary/Treasurer/Chief Executive/Commissioner of Finance

- (3) Endorse checks and orders for the payment of money and withdraw funds on deposit with Woodlands National Bank Number of authorized signatures required for this purpose \_\_2\_ of the above and District II Representative.
- BE IT FURTHER RESOLVED, that Woodlands National Bank may deal with any and all of the persons directly or indirectly by the foregoing resolution empowered, as though they were dealing with the Band directly.
- BE IT FURTHER RESOLVED, that the Secretary/Treasurer of the Band be and hereby is authorized, empowered and directed to certify, under the seal of the Band, to Woodlands National Bank: (a) a true copy of this Resolution; (b) specimen signatures of each and every person by this Resolution empowered; and (c) a certificate which, if required by Woodlands National Bank shall be supported by an opinion of legal counsel of the Band, or other counsel satisfactory to Woodlands National Bank that the Band is duly organized and existing, that its statutes empower it to transact the business by this Resolution, and that no limitation has been imposed upon such powers by the laws of the Band or otherwise.

- BE IT FURTHER RESOLVED, that Woodlands National Bank may rely upon the certified copy of the resolutions, specimen signatures, and certificate, as continuing fully effective unless and until Woodlands National Bank shall receive due written notice of change or rescission, and the dispatch or receipt of any other form of notice shall not constitute a waiver of this provision, nor shall the fact that any person hereby empowered ceases to be an officer of the Band or becomes an officer under some other title, in any way affect the powers hereby conferred, but the failure to supply a specimen signature shall not invalidate any transaction where the party authorizing the same has been actually empowered thereto by or in conformity with these resolutions; and
- BE IT FURTHER RESOLVED, that in the event of any change in the office or powers of persons hereby empowered, the Secretary/Treasurer shall certify such changes to Woodlands National Bank in writing in the manner herein above provided, which notification, when received, shall be adequate both to terminate the powers of the persons thereto fore authorized, and to empower the persons thereby substituted; and
- BE IT FURTHER RESOLVED, that the Chief Executive, Secretary/Treasurer, District II Representative and Commissioner of Finance of the Band be, and hereby are, authorized and empowered to countersign items as aforesaid; and
- BE IT FURTHER RESOLVED, that this resolution and the certificates actually furnished to Woodlands National Bank by the Secretary/Treasurer of the Band pursuant thereto, be and they hereby are made irrevocable until written notice of the revocation thereof shall have been received by Woodlands National Bank; and
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 8th day of July, 2010 at Vineland, Minnesota by a vote of 3 FOR,0 AGAINST, 0 SILENT.
