## JOINT RESOLUTION 13-04-21-10

A JOINT RESOLUTION APPROVING THE SUBMISSION OF AN INDIAN EDUCATION – DEMONSTRATION GRANT TO THE US DEPARTMENT OF EDUCATION TO HELP FUND THE COLLABORATION BETWEEN MILLE LACS NAY AH SHING SCHOOLS AND THE ONAMIA SCHOOL DISTRICT TO OPERATE A COLLEGE PREPATORY PROGRAM

- the Mille Lacs Band Assembly is the duly elected governing body for the WHEREAS. Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Mille Lacs Band Assembly is empowered by 3 MLBSA § 2(d) to adopt resolutions to promote the general welfare of the people; and
- the Chief Executive is empowered to exercise all executive political authority for WHEREAS. the Mille Lacs Band of Ojibwe; and
- the Mille Lacs Band Assembly and the Chief Executive recognizes the importance of WHEREAS. providing access to college preparatory programs for secondary students; and
- the Mille Lacs Band of Ojibwe fully supports college preparatory programs for secondary WHEREAS, school students designed to increase competency and skills in challenging subject matters to enable Indian students to successfully transition to postsecondary education.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly and Chief Executive does hereby authorize and approve the submission of a grant to U.S. Department of Education for the purpose of collaboration with Onamia schools for a college preparatory program.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 17th day of December, 2009 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
