JOINT RESOLUTION 14-02-13-10

A JOINT RESOLUTION APPROVING THE SUBMISSION OF THE STRENGTHENING OF PUBLIC HEALTH INFRASTRUCTURE GRANT APPLICATION FOR IMPROVED HEALTH OUTCOMES TO THE US DEPARTMENT OF HEALTH AND HUMAN SERVICES.

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive have established as a priority the improvement of the social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive recognizes the importance of raising public health awareness by teaching prevention strategies to Band members and helping the Mille Lacs Public Health Department have a more efficient and effective infrastructure; and
- WHEREAS, the Mille Lacs Band of Ojibwe fully supports the hiring of a Prevention Specialist
 Manager whose duties may include, but are not limited to, overseeing teen pregnancy,
 drug abuse, and gang prevention efforts conducted by the Mille Lacs Band Public Health
 Department.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly does hereby authorize and approve the submission of a strengthening of Public Health Infrastructure grant to the US Department of Health for the purpose of hiring a Prevention Specialist Manager.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 2nd day of August, 2010 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
