**RESOLUTION 14-01-118-10**

**A RESOLUTION RESCINDING RESOLUTION # 12-03-81-07  
AUTHORIZING A RESIDENTIAL LAND LEASE WITH AN ATTACHED  
MORTGAGE TO [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home, and

WHEREAS, Resolution #12-03-81-07, authorized a land lease for residential purposes to be given to [REDACTED] for establishing his home with financing obtained from the Mille Lacs Band of Ojibwe Housing Department; and

WHEREAS, the residential lease was to be for a period of 35 years and renewable for an additional 15 years, and is subject to the lease provisions, effective July 2, 2007; and

WHEREAS, said land is described as follows:

Part of Tract 410 TF 101 described as Lot Thirty-three (33), Block Two (2), Port Mille Lacs, Golf Acres North.

And

Part of Tract 410 TF 106 described as follows Lot Thirty-two (32), Block Two (2), Port Mille Lacs, Golf Acres North.

And.

Part of Tract 410 TF 148 described as Lot Thirty-one (31), Block Two (2), Port Mille Lacs, Golf Acres North. Further described as:

Lots 31, 32, 33, Block 2 of Port Mille Lacs Golf Acres North, Fourth Principal Meridian, Mille Lacs County, Minnesota, Survey Job # 5244-003 dated 4/6/07, Houston Engineering, Inc. This lease site is 1 acre more or less.

WHEREAS, rescinding Resolution #12-03-81-07 is being requested due to none use; and


