RESOLUTION 14-02-18-10

A RESOLUTION RESCINDING RESOLUTION # 09-03-74-01 <u>AUTHORIZI</u>NG A RESIDENTIAL LAND LEASE TO

- the Mille Lacs Band Assembly is the duly-elected governing body of the Mille WHEREAS. Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home, and
- WHEREAS, Resolution #09-03-74-01, authorized a residential land lease to be given to and
- the residential lease was to be for a period of 25 years and renewable for an WHEREAS, additional 25 years, and is subject to the lease provisions, effective upon date of approval; and
- WHEREAS, Part of Tract 410 TF131 located in the Northeast one-quarter (NE 1/4) of the Northeast one-quarter (NE 1/4) of Section Seven (7), Township Forty North (T40N), Range Twenty West (R20W), Fourth Principal Meridian, Pine County, Minnesota more particularly described as follows:
 - Parcel B of Westwood Wellen Survey #20005613 Dated June 28, 2000. The leasesite is approximately 1 acre more or less.
- WHEREAS, rescinding Resolution #09-03-74-01 is being requested by the Lessor due to nonuse of the site.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the Rescinding of Band Resolution #09-03-74-01; and

BE IT FURTHER RESOLVED, that the land will revert to the Mille Lacs Band of Ojibwe.
