
**A JOINT RESOLUTION APPROVING THE SUBMISSION OF THE
NATIVE NATIONS CAPACITY BUILDING GRANT APPLICATION TO
THE BUSH FOUNDATION TO SUPPORT SELF-DETERMINATION
FOR THE MILLE LACS BAND OF OJIBWE**

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Mille Lacs Band Assembly has established as a priority the improvement of the social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Mille Lacs Band Assembly is committed to listening to Band Members and assisting them in fulfilling their needs; and
- WHEREAS, the Mille Lacs Band Assembly also supports the Band's vision of understanding the importance of preserving history, culture, and language, as well as promoting economic development; as defined in the Strategic Plan; and
- WHEREAS, the Mille Lacs Band of Ojibwe fully supports the goal of the Bush Foundation to strengthen organizational, community, and individual leadership of sovereign nations.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly and Chief Executive hereby support the submission of a grant application to the Bush Foundation to assist in strengthening the organizational workings of its government as well as individual leadership.

WE DO HEREBY CERTIFY, that the foregoing Joint Resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 6th day of November, 2009 at Hinckley, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
