JOINT RESOLUTION 13-04-02-10

A JOINT RESOLUTION OFFICIALLY AUTHORIZING THE BAND WEBSITE KNOWN AS WWW.MILLELACSBAND.COM

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, the Chief Executive is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Chief Executive and Band Assembly acknowledge that a new Band website with the e-mail address of www.millelacsband.com is currently the official website of the Mille Lacs Band of Ojibwe government; and
- WHEREAS, the Band Assembly further acknowledges that the cost to keep the website in operation for three (3) years is \$214.00; and
- WHEREAS, the Commissioner of Administration is responsible for the program operations of the I.S. Department and will ensure that the operations cost is paid to maintain the website; and
- WHEREAS, the Band Assembly and Chief Executive approve of the website and approve of the Commissioner of Administration maintenance of costs responsibilities.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band of Ojibwe hereby authorize and approve of the website known as www.millelacsband.com as the official website of the Mille Lacs Band of Ojibwe government and hereby approve of the Commissioner of Administration paying the maintenance costs of \$214.00 for three (3) years.


