JOINT RESOLUTION 14-01-140-10

A JOINT RESOLUTION APPROVING THE SUBMISSION OF A CENTERS OF EXCELLENCE IN EARLY CHILDHOOD GRANT APPLICATION TO THE ADMINISTRATION FOR CHILDREN AND FAMILIES, OFFICE OF HEAD START TO HELP FUND THE MILLE LACS BAND OF OJIBWE DEPARTMENT OF EDUCATION

- the Mille Lacs Band Assembly is the duly elected governing body for the WHEREAS, Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- the Chief Executive of the Band is empowered to exercise the Executive Branch powers WHEREAS. of the Band; and
- the Mille Lacs Band Assembly and Chief Executive have established as a priority the WHEREAS, improvement of the social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- the Mille Lacs Band Assembly and Chief Executive recognizes the importance of WHEREAS. providing access to the enhancement of literacy and math skills into our Head Start classrooms by hiring a school readiness specialist; and
- the Mille Lacs Band of Ojibwe fully supports the recognition of our Head Start Program WHEREAS. to produce positive, measurable outcomes for children's school success, for families supporting children's learning, and for increased staff competency.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly does hereby approve the submission of a grant to the Administration for Children and Families, Office of Head Start for the purpose of enhancing literacy and math skills for children and teachers through the employment of a school readiness specialists in our Head Start programs.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 6th day of July, 2010 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
