JOINT RESOLUTION 14-02-12-10

A JOINT RESOLUTION TO APPROVE THE ONE YEAR AND FIVE YEAR HOUSING PLANS AS SUBMITTED BY THE MILLE LACS RESERVATION HOUSING AUTHORITY AS THE TRIBALLY DESIGNATED HOUSING AUTHORITY (TDHE)

WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe, and;

WHEREAS, the goal of the Mille Lacs Band of Ojibwe is to promote the general welfare of Band members by providing homes in safe and healthy environments and to promote economic self-sufficiency for tribal members, and;

WHEREAS, Congress enacted P.L. 104-330, 1996 HR 3219, the Native American Housing Assistance and Self-Determination Act, wherein Congress found that pursuant to treaties, statutes, and the general course of dealing with Indian tribes has a trust responsibility for Indian tribes and their members and improve their housing conditions and socioeconomic status, and;

WHEREAS, Congress determined that federal assistance is provided to meet these responsibilities in a manner that recognizes the right of Indian self-determination and tribal self-governance by making such assistance available to the Indian Tribes or Tribally Designated Entities by enactment of this law, and;

WHEREAS, the Band has appointed the Mille Lacs Reservation Housing Authority as the Tribally Designated Housing Entity (TDHE) pursuant to Resolution Number 07-03-81-97.

NOW THEREFORE BE IT RESOLVED, that the Mille Lacs Band Assembly of the Mille Lacs Band of Ojibwe do hereby approve the one-year and five-year plan and the submission of the plan to the United States Department of Housing and Urban Development.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislative being present on the 22nd day of July, 2010 at Isle, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
