## **JOINT RESOLUTION 14-01-37-10**

A JOINT RESOLUTION APPROVING THE SOLICITOR GENERAL'S OFFICE AS THE OFFICE RESPONSIBLE FOR CONDUCTING THE CRIMINAL BACKGROUND INVESTIGATIONS TO ESTABLISH THE ELIGIBILITY OF CANDIDATES FOR THE 2010 MCT ELECTION ON THE MILLE LACS RESERVATION

- WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly is empowered by Band Statue 3 MLBSA § 2, to adopt Resolutions which promote the general welfare of the Mille Lacs Band and its members; and
- WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Mille Lacs Band of Ojibwe is one (1) of the six (6) Ojibwe Bands forming the Minnesota Chippewa Tribe ("MCT"); and
- WHEREAS, Article IV of the Minnesota Chippewa Tribe Revised Constitution mandates that all tribal elections on the six (6) reservations shall be in accordance with a uniform election ordinance adopted by the Tribal Executive Committee ("TEC"), the entity recognized as the MCT governing body; and
- WHEREAS, the Secretary-Treasurer and the Chief Executive are voting members of the TEC; and
- WHEREAS, the MCT Election Ordinance #10 (As Amended to December 8, 2009) has been adopted by the TEC as the official Election Ordinance for the 2010 MCT Election to be held on the Mille Lacs Reservation; and
- WHEREAS, Chapter 1, Section 3, Subsection D. 5. of the MCT Election Ordinance #10 (As Amended to December 8, 2009), entitled <u>Conducting Criminal History Check</u> authorizes each Band governing body as the entity responsible for conducting the required criminal background investigations; and
- WHEREAS, Chapter 1, Section 3, Subsection C. 4. of the MCT Election Ordinance #10 (As Amended to December 8, 2009), requires that each Band governing body certify the eligible candidates in accordance with the MCT Constitution and the MCT Election Ordinance; and

- WHEREAS, the Mille Lacs Band of Ojibwe approves the Band's Office of Solicitor General as the office responsible for conducting the required criminal background investigations to establish the eligibility of candidacy for the 2010 MCT Election; and
- WHEREAS, the results of the criminal background investigations are confidential and shall be sealed by the Solicitor General upon completion and remain sealed until personally delivered to the Joint Session on the date established for certification of the candidates when the envelope(s) will be opened by the elected officials; and
- WHEREAS, the Solicitor General shall also ensure that any Office of Solicitor General employee who may handle the confidential results of the criminal background investigations of the candidates be required to maintain the confidential nature of these findings and shall ensure that no disclosures to third parties be made.
- NOW THEREFORE BE IT RESOLVED, the Band Assembly and Chief Executive hereby approve the Office of the Solicitor General as the office responsible for conducting the criminal background investigations to establish the eligibility for candidacy for the 2010 MCT Election and require that the Solicitor General and his staff maintain the confidentiality of these findings in a sealed envelope until delivered to the Joint Session on the date set for the certification of the candidates.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 1<sup>st</sup> day of February, 2010 at Vineland, Minnesota by a vote of \_3\_FOR, \_0\_AGAINST, \_0\_SILENT.
