RESOLUTION 14-02-15-10

**A RESOLUTION RESCINDING RESOLUTION # 12-03-60-07
AUTHORIZING A RESIDENTIAL LAND LEASE WITH AN ATTACHED
MORTGAGE THROUGH MINNESOTA CHIPPEWA TRIBE HOME
LOAN PROGRAM TO [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home, and

WHEREAS, Resolution #12-03-60-07 authorized a land lease for residential purposes to be given to [REDACTED] for establishing her home with financing obtained from the Minnesota Chippewa Tribe Home Loan Program; and

WHEREAS, the residential lease was to be for a period of 25 years and renewable for an additional 25 years, and is subject to the lease provisions, effective April 19, 2007; and

WHEREAS, said land is described as follows:

A part of Tract 410 TF 200 located in Section Seven (7), Township Forty-three North (43N), Range Twenty-seven West (27W), Fourth Principal Meridian, Mille Lacs County, Minnesota, described as follows:

Lot One Hundred Seventy-three (173) and Lot One Hundred Seventy-four (174) Port Mille Lacs Plat recorded in the county of Mille Lacs.

WHEREAS, rescinding Resolution #12-03-60-07 is being requested by the lessor due to nonuse.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the rescinding of Resolution #12-03-60-07; and
