A JOINT RESOLUTION APPROVING THE SUBMISSION OF THE NATIVE NATIONS CAPACITY BUILDING GRANT APPLICATION TO THE BUSH FOUNDATION TO SUPPORT SELF-DETERMINATION FOR THE MILLE LACS BAND OF OJIBWE

- the Mille Lacs Band Assembly is the duly-elected governing body of the Mille WHEREAS, Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Mille Lacs Band Assembly has established as a priority the improvement of the social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Mille Lacs Band Assembly is committed to listening to Band Members and assisting them in fulfilling their needs; and
- WHEREAS, the Mille Lacs Band Assembly also supports the Band's vision of understanding the importance of preserving history, culture, and language, as well as promoting economic development; as defined in the Strategic Plan; and
- WHEREAS, the Mille Lacs Band of Ojibwe fully supports the goal of the Bush Foundation to strengthen organizational, community, and individual leadership of sovereign nations.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly and Chief Executive hereby support the submission of a grant application to the Bush Foundation to assist in strengthening the organizational workings of it's government as well as individual leadership.
- WE DO HEREBY CERTIFY, that the foregoing Joint Resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 6th day of November, 2009 at Hinckley, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
