**JOINT RESOLUTION 13-04-08-10**

**A JOINT RESOLUTION APPROVING THE SUBMISSION OF THE FAMILY DECISION MAKING GRANT APPLICATION TO THE MINNESOTA DEPARTMENT OF HEALTH AND HUMAN SERVICES FOR THE IMPLEMENTATION OF A MILLE LACS RESERVATION BASED FAMILY DECISION MAKING PROGRAM FOR THE HEALTH AND HUMAN SERVICES**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, the Mille Lacs Band Assembly has established as a priority the improvement of the social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and

WHEREAS, the Mille Lacs Band Assembly recognizes that quality health care and protection of its youth will benefit the entire Band membership;

WHEREAS, the Mille Lacs Band Assembly desires permanency and reunification for its out-of-placement youth and fully supports the goal of the Minnesota Department of Health and Human Services to assist in improving the well-being, strength, and stability of families.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly and Chief Executive hereby support the submission of a grant application to the MN Department of Health and Human Services for the implementation of a reservation based family decision making program.

WE DO HEREBY CERTIFY, that the foregoing Joint Resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 6th day of November, 2009 at Hinckley, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
