RESOLUTION 14-01-94-10

A RESOLUTION MODIFYING RESOLUTION # 06-01-92-94 WHICH AUTHORIZED LAND LEASES FOR RESIDENTIAL PURPOSES TO MILLE LACS RESERVATION HOUSING AUTHORITY

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,
- WHEREAS, Resolution # 06-01-92-94 modified Resolution #05-04-11-94 which authorized a land lease to the Mille Lacs Reservation Housing Authority for the purpose of establishing home sites; and,
- WHEREAS, Resolution #06-01-92-94 identified individuals who are to sublease the sites; and,
- WHEREAS, the lease is for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective May 24, 1994 for the property described herein; and,
- WHEREAS, Removal of lease description 19 and the sublease name Trisha Moose is requested from Resolution #06-01-92-94; and
- WHEREAS, Land description 19 is described as follows:
- That part of Indian Allotment No. 221 in the NW ¼ of Section 18, Twp 41N, Range 17W, Pine County, State of Minnesota, described thus: Commencing at the NW corner of said Section 18 being a found C.I.N. monument, thence South 592.33', thence East 33' to point of beginning, thence East 210', thence North 250', thence West 210', thence South 250' to the point of beginning.; and
- WHEREAS, removal of lease description 19 stated above from Resolution # 06-01-92-94 due to the Mille Lacs Reservation Housing Authority giving Trisha Moose a sublease.
- WHEREAS, Ms.Trisha Moose is no longer at that site.


