RESOLUTION 14-01-107-10

A RESOLUTION MODIFYING AND CANCELLING RESOLUTION # 11-02-26-05 AUTHORIZING A RESIDENTIAL LAND LEASE WITH AN ATTACHED MORTGAGE TO

(Part of Tract 410 T 1001)

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home, and
- WHEREAS, Resolution #11-02-26-05, authorized a land lease for residential purposes to be given to for establishing his home with financing obtained from the Mille Lacs Band of Ojibwe Housing Department; and
- WHEREAS, the residential lease was to be for a period of 35 years and renewable for an additional 15 years, and is subject to the lease provisions, effective December 2, 2004; and
- the lease description in Resolution # 11-02-26-05 was incorrectly identified as WHEREAS, Part of Tract 410 T 1001 located in the North one-half (N ½) of the Northeast one-quarter (NE ¼) of Section Twenty (20), Township Forty-three North (T43N) Range Twenty-seven West, (R27W) Mille Lacs County, Fourth Principal Meridian, more particularly described as follows:

Lot Thirty-eight (38), Bugg Hill Plat. The lease site is approximately 1 acre more or less; and

WHEREAS, said lease description should have been described as follows: Part of Tract 410 T 1001 located in the North one-half (N ½) of the Northeast one-quarter (NE ½) of Section Twenty (20), Township Forty-three North (T43N) Range Twenty-seven West, (R27W) Mille Lacs County, Fourth Principal Meridian, more particularly described as follows:

> Lot Thirty-nine (39), Bugg Hill Plat. The lease site is approximately 1 acre more or less; and
