## **RESOLUTION 14-01-117-10**

## A RESOLUTION AUTHORIZING A LAND LEASE FOR RESIDENTIAL PURPOSES TO MILLE LACS BAND HOUSING DEPARTMENT (MLBHD) That Part of Tract 410 T 75

WHEREAS. the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, the Mille Lacs Band Housing Department respectfully requests a land lease for residential purposes; and

WHEREAS, the lease will be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and

WHEREAS, said land is described as follows:

> That Part of Tract 410 T 75 located in the Southeast one quarter of the Southwest one quarter of the Southwest one quarter of the Northwest one quarter and the South one half of the Southwest one quarter of the Southwest one quarter of the Southwest one quarter of the Northwest one quarter and North one half of the Southeast one quarter of the Northwest one quarter of Northwest one quarter of the Southwest one quarter. (SE1/4SW1/4SW1/4NW1/4, S1/2SW1/4SW1/4SW1/4NW1/4, N1/2SE1/4NW1/4NW1/4SW1/4) in Section Twenty-seven (27), Township Forty-three North (T43N), Range Twenty-seven West (R27W), on Mille Lacs Reservation, Fourth Principal Meridian, Mille Lacs County, Minnesota, Vineland Hills, Allotment A-75. This lease site is 1 acre more or less.

More particularly described as:

Beginning at the Southwest corner of the SW1/4 of NW ¼, thence 77.8 ft. North, thence 650 ft. East, thence 40 ft. South to the point of beginning, thence 330.0 ft. North, thence 100 ft. West, thence 273 ft. South, thence running Southeasterly (approximately 102 ft.) parallel with road to point of beginning.

- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby authorizes a land lease for the property described herein for residential purposes be issued to the Mille Lacs Band Housing Department for a period of 25 years, renewable for an additional 25 years subject to the lease provisions, effective upon date of approval; and
- BE IT FURTHER RESOLVED, that the lessee will utilize the land in conformity with the provisions of the lease within twelve (12) months of the effective date of the lease, and if all terms of the lease are not met, the land will revert to the Mille Lacs Band of Ojibwe; and
- BE IT FURTHER AND FINALLY RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above-described property for more than thirty (30) consecutive days after the 1<sup>st</sup> year anniversary of the effective date of the lease without the prior approval of the Band Assembly.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 7th of June, 2010 at Hinckley Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
