RESOLUTION 14-01-92-10

A RESOLUTION MODIFYING RESOLUTION # 06-01-92-94 WHICH AUTHORIZED LAND LEASES FOR RESIDENTIAL PURPOSES TO MILLE LACS RESERVATION HOUSING AUTHORITY

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,
- WHEREAS, Resolution #06-01-92-94 modified Resolution #05-04-11-94 which authorized a land lease to the Mille Lacs Reservation Housing Authority for the purpose of establishing home sites; and,
- WHEREAS, Resolution #06-01-92-94 identified individuals who are to sublease the sites; and,
- WHEREAS, the lease is for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective May 24, 1994 for the property described herein; and,
- WHEREAS, Removal of Beverly Benjamin as the sublessee is being requested from Resolution #06-01-92-94: and,
- WHEREAS, Lease description 2 which was subleased to Beverly Benjamin is described as follows:
Part of Tract 410 TF 56 described as follows:
Located in Township Forty-three North, (T43N), Range Twenty-seven West (R27W), Section Twenty-one (21), Kathio Township, Southwest Quarter of the Southwest Quarter (SW1/4SW1/4), Mille Lacs County, Mille Lacs Reservation, Fourth Principal Meridian.
- Further described as:
Block 02, Lot 07, North Connection Road. This lease site is 1 acre more or less.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby authorizes modification of Resolution # 06-01-92-94, by removing Beverly Benjamin as the sublessee and all other terms and conditions shall remain the same.


